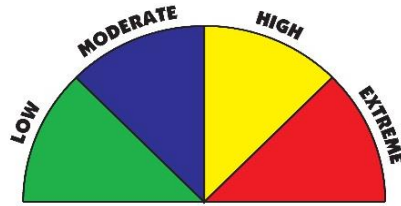


# DFPA Public Use Restriction, 2018

<p><b>Open Fires Are Restricted</b> including campfires, charcoal fires, cooking fires and warming fires, except at designated sites. <p><b>Motor Vehicles</b> including motorcycles and all-terrain vehicles, are only allowed on improved roads free of flammable vegetation, except for the cultivation and harvest of agricultural crops. In addition, each vehicle traveling on forestlands, except on state highway, county roads and driveways must have one shovel and one gallon of water or a 2.5 lb. or larger ABC fire extinguisher. <p><b>Non-Industrial Powersaws On Private Property</b></p> <p>When allowed each saw being used must have one shovel and one fire extinguisher of at least 8 ounce capacity. <p><b>Cutting, Grinding, or Welding of Metal on Private Property</b></p> <p>When allowed, is restricted to areas that are cleared of flammable materials and have either a charged hose or 2.5 lb. or larger ABC fire extinguisher.</p>	Allowed All Day	Allowed Before 1 pm or after 8 pm	Allowed Before 10 am or after 8 pm	Prohibited

<p><b>Cutting, Trimming or Mowing of Dried, Cured Grass</b></p> <p>The culture and harvest of agricultural crops is exempt from this requirement.</p>	Allowed All Day	Allowed Before 1 pm or after 8 pm	Allowed Before 10 am or after 8 pm	Prohibited

<p><b>Power Driven Machinery</b></p> <p>not specifically mentioned above and used on any non-industrial improvement or deveolopment on private property is restricted. Each piece of equipment must have a shovel and a 2.5 pound or larger ABC fire extinguisher. A one hour fire watch is required once work has completed for the day.</p>	Allowed All Day	Allowed Before 1 pm or after 8 pm	Allowed Before 10 am or after 8 pm	Prohibited
